

Middle Ridge Retreat Covid-19 Compliance.

- 1. Overview:
- The "Business" is operated, as a vacation rental, under the name of Middle Ridge Retreat, 30560 Middle Ridge Rd. Albion Ca. 95410
- 2. Cleaning:
- We use an "independent contractor" for cleaning. She has agreed to wear a mask and gloves when entering and performing cleaning services, as well as sanitize her hands regularly.
- She has also agreed to not enter the premises if she is experiencing any "symptoms', per
- o She has agreed to follow all CDC Guidelines.
- 3. Signage:
- Sign will be posted at the front door to inform guests, subcontractors etc. that they should not enter the building if they have a cough, shortness of breath, difficulty breathing, fever, chills, muscle pain, sore throat, or loss of smell or taste.
- 4. Disinfection Protocols
 - There will be seven (7) days between guests (per CDC, only normal cleaning needed.
 - o In addition: all "high touch" surfaces will be cleaned with disinfectant.
 - All laundry as well as comforters, mattress pads, towels will be washed on "extra hot" setting.
- 5. Guest compliance with Health Orders

- 6. Prevention of "gatherings":

- 7. Guest PPE and Sanitization:
 - All guest will be provided with facial covering (masks)
 - All guests will be provided with latex gloves.
 - Hand sanitizer will be provided in the kitchen as well as both bathrooms.
 - All guests will be provided with disinfecting wipes
- 8. General Measures:
 - We will remove all "shared" condiments, cooking oil, food etc. from the premises.
- 9. Hot Tub.
- o The hot tub will be locked and turned off.
- 10. Payment Processing
 - All payments will be processed either through VRBO or AirBnb

- In the event that someone in your party develops symptoms, the County of Mendocino will require that the person experiencing symptoms "isolate' at Middle Ridge Retreat, and that all others shall "quarantine" in a separate room, at Middle Ridge Retreat, for 14 days. - This rental is limited to one "family unit" plus children. Gatherings are not allowed.
