12. Describe the signed agreement you have with guests regarding compliance with County of Mendocino Public Health Orders.

Signed agreement will be required by all guests before they arrive. agreement will require the names and phone numbers of each adult guest, acknowledgement and agreement to comply with county SIP order, and comply with all isolation/quarantine orders. Agreement will also address cost of food, and additional days rent if guest is required to isolate/quarantine. Agreement will contain a disclaimer that it is the obligation of the guests to fully comply with any such allocation of costs without recourse against the County of Mendocino.

13. In the event your facility has a guest who contracts Covid-19, what are your plans for quarantine and isolation?

We only have one 600 square foot unit and the guests would have to isolate there at their expense. We would have to cancel any down stream reservations that conflict with this. Guests are informed of this when they make the reservation.
